BACKGROUND

- 1. Inquiries are received at the front desk. Logged, numbered and emailed to the City Administrator and departments who will handle the response.
- 2. The email with the Inquiry includes the steps below.
 - Step 1. Print a working copy for yourself.
 - Step 2. Research issue and follow up with citizen that submitted the inquiry by letter, email or phone. Providing them with policies and/or procedures s that apply to the concern and let them know how the inquiry will be handled.
 - Step 3. Complete the Official Response on form summarizing the action and the date you followed up. Attach all emails, letters or other documents.
 - Step 4. Route fully completed inquiry forms to the City Administrator to close and sing off.
 - Step 5. City Administrator will sign off and return to City Recorder to log, retain and report status to Council quarterly.
