## 1. CALL TO ORDER

Chair Fox called the meeting to order at 6:05 p.m.

#### 2. ROLL CALL

Ms. Egbert called roll. A quorum was present.

#### 3. MINUTES REVIEW

**MOTION:** Ms. Kroeger moved, seconded by Mr. Dawson, to approve the Urban Renewal Agency (URA) May 25th, 2021 meeting minutes. The motion passed – 7:0.

#### 4. PUBLIC COMMENT

Chair Fox called for public comment. There was none.

#### 5. URBAN RENEWAL AGENCY BUDGET MESSAGE

Mr. Gaines took the podium and reminded the Council that staff had been investigating why taxes were lower than anticipated. He invited Ms. Heath to elaborate.

Ms. Heath expressed that she had asked the County for a report on the value and tax receipts of every property in the county. She indicated that several properties with lowered values had been identified, one of which was substantial. Based on that information, an analysis was created. She assured the Council that another conversation with the County would be conducted to discover the cause of the reductions in property values. She shared that the County would reassess the Coburg industrial area later in 2022.

Chair Fox inquired if "every property" included community property. Ms. Heath clarified that the report only covered properties within the URA. Mr. Fox asked how many had reduced in value. Fifteen to twenty, Ms. Heath responded. Mr. Fox wondered whether the County notified staff of such changes. Ms. Heath said the County did not.

Mr. Gaines called for questions on the budget. Ms. Landry inquired as to why the received amount on the Tax Receipt History for 2022-23 was lower. Mr. Gaines explained that it was based on the 98% projected in the % Received column.

**6. PROPOSED FY 2022-23 URBAN RENEWAL AGENCY BUDGET REVIEW & DISCUSSION** Chair Fox called for discussion. There was none.
