REQUESTED COUNCIL ACTION

Adopt Resolution 2022-12 to receive State Revenues for FY 2022-2023 pursuant to ORS 221.770

Suggested Motion; "I move to approve Resolution 2022-12 A Resolution declaring the City's Election to Receive State Revenues."

BACKGROUND

The State of Oregon Department of Revenue requires Cities to pass by resolution declaring the City's election to receive state revenues on an annual basis. The Budget Committee held a public hearing on May 31, 2022 giving citizens an opportunity to comment on use of State Revenue Sharing. There will be another Public Hearing to hear citizen's comments at the City Council meeting June 14, 2022 before the Resolution is adopted. To receive the State revenue this Resolution must be adopted and sent to State of Oregon Department of Administrative Services.

RECOMMENDATION AND ALTERNATIVES

Recommendation is to approve Resolution 2022-12 or elect not to receive State Revenues and decrease the revenues and expenditures in the associated appropriation.

BUDGET / FINANCIAL IMPACT

State Shared Revenues provide the City with an annual revenue stream of approximately

\$15,640. Approval of the resolution will insure the City will receive State Shared Revenues for FY 2022-23.

PUBLIC INVOLVEMENT

In order to receive distributions the City must:

- 1. Hold at least one public hearing before the Budget Committee to discuss possible uses of the funds, which was completed May 31, 2022.
- 2. Hold an additional public hearing before the City Council on the proposed uses of the funds in relation to the entire Budget. This is to be completed at the June 14, 2022 meeting.
