CALL THE URBAN RENEWAL AGENCY MEETING TO ORDER

Chair Bell called the meeting to order at 6:01 pm.

ROLL CALL

Ms. Egbert called roll. A quorum was present.

BUSINESS ITEMS

1. Minutes Februrary 14, 2023 Urban Renewal Agency.

MOTION: Member Engebretson moved, seconded by Member Blain to approve the February 14, 2023 minutes, as presented. The motion passed unanimously (6-0-0).

2. Ms. Heath gave a Financial Update for Urban Renewal Agency. Discussion ensued.

Member comments and questions included the revenue source, specifically which fund, whether the Fire Department is in the URA

boundary, and the reasoning behind leaving some industrial areas out of the URA District.

Ms. Heath clarified that the source for revenue is from taxes and interest, which comes from the Urban Renewal District. The Fire Department is located in the URA boundary, and the reasoning behind leaving certain properties out of the URA District will need to be reviewed.

3. **Public Hearing**

Chair Bell opened the public hearing at 6:07 p.m.

Ms. Heath presented **RESOLUTION 2023-01-U:** A RESOLUTION ADOPTING THE AGENCY BUDGET FOR FISCAL YEAR 2023-24 AND CREATING EXPENDITURE APPROPRIATIONS. Discussion ensued.

Member comments and questions included whether the audit was necessary and whether the amount had changed from the previous year.

Ms. Heath confirmed that the audit was necessary and the amount had changed due to updating the review process, which was projected to be higher this year.

There were no public comments.

Chair Bell closed the public hearing at 6:10 p.m.

MOTION: Member Blain moved, seconded by Member Wells, to adopt Resolution No. 2023-01-U, A Resolution Adopting the Agency Budget for Fiscal Year 2023-24 and Creating Expenditure Appropriations. The motion passed unanimously (6-0-0).
