CALL MEETING TO ORDER

1. PUBLIC HEARING: SR 01-22 Site Review & CUP 01-22 Conditional Use Permit

"Willamette Forks" Restaurant & Brewery, 91032 S Willamette St.

Ms. Winner presented the application and Staff recommendations.

Applicant Stephen Sheehan declined to make a presentation.

One piece of written testimony in opposition was entered, citing concerns about noise, odors and property values. Mr. Sheehan addressed the concerns.

Commissioner Marshall requested a definition of "serving station." Mr. Sheehan provided it. Commissioner Marshall asked about outdoor cooking and the placement of the crosswalk.

MOTION: Commissioner Doyle moved to close the Public Hearing, seconded by Commissioner Marshall. The motion passed unanimously, 4:0.

The Public Hearing was closed at 6:40 p.m.

Commissioner Marshall inquired if the Commission could add conditions. On confirmation, he

suggested adding the condition of an included smoking area.

Chair Bell re-opened the Public Hearing at 6:44 p.m. to allow Mr. Sheehan to address the suggestion. Mr. Sheehan stated that he did not wish to allow smoking on the property.

Chair Bell closed the Public Hearing at 6:46 p.m.

MOTION: Commissioner Doyle moved to approve the application and adopt the findings and conditions presented in the Staff Report, seconded by Commissioner Marshall.

The motion passed unanimously, 4:0.
