

Why Do We Need to Consider a Rate Increase?

Due to the very significant increase in inflation and the expenses to operate our sewer and water systems, and the rising costs of projects needed to insure safe and reliable water in Coburg now and in the future, City Council began discussing utility rate increases nearly a year ago. These discussions are guided by the Water Master Plan that includes:

- Additional Water Source
- Extending Water to the Eastside of I-5
- Aging Water Infrastructure
 Replacement
- Upgrades to Utility Monitoring





The first Water Master Plan was adopted in Coburg in 1966 and was amended in 2016. Implementation of the plan began in 2019.

The city applied for and received loans in the amount of \$5.5 million for funding the projects necessary. The debt of the water department must be paid back with user fees and reserves over a 30-year period.

The city has received an analysis of the updated costs for completing the water projects. Operational costs have increased more than 8% in the past year. There also has been greater increases in construction costs, operations of the utilities, as well as capital projects. These factors require the City Council to consider utility fee increases.

How Are Rates Set?

The city sets water and sewer rates by estimating the current and long-term costs of providing these services. Costs of on-going materials and services, personnel, and debt service are all estimated out 20 years to make sure that the city continues to maintain a high level of on-going service. This analysis is performed annually in order to update new information, and to consider changes in costs associated with operating the utilities.

How Will My Rates Change?

Utility bills include water, sewer, transportation utility fee, tree fee. The base monthly bill for a single family residential customer using 700 cubic feet (5,236 gallons) per month is currently \$148.70.

April 26, 2022 - The City Council requested staff to budget a 1.5% sewer fee and 3% water fee increase. The Council acknowledged that a higher increase may be necessary when the financial analysis was completed.

Residential water currently pays a monthly base rate of \$53.00. A 3% increase would add \$1.59 a month. The total residential base water rate would be \$54.59.

Residential Sewer currently pays a monthly base rate of \$86.70. A 1.5% increase would add \$1.30 a month. The total residential sewer bill would be \$88.00.

A 3% water and 1.5% sewer increase would increase the base bill \$2.89 a month, the total monthly bill would be \$151.59. **However, this should be considered a placeholder for rate increases and may not reflect the final increases which will be decided by the City Council at their May meeting.**
