The new fareboxes will be installed on new buses arriving in FY21. The new fareboxes accept a wide variety of bus fare payment options, (i.e. cash, swipe card, and credit card) and improve operations and security. The new equipment will be used in conjunction with the Genfare Odyssey electronic validating farebox system, which was purchased in 2009, per Resolution #386-09. Consequently, the vendor is considered the only known source to provide the new equipment.

Funds are budgeted in the FY21 Budget: Transportation Fund –Transportation –FTA - Metra FTA - Capital Expenditures over \$5,000; 0751-610-2400-MFTA-7761 (FTA 80% and City 20%).
