- **PHASE II: 821 CAMERAS; 97% COMPLETED**
 - Civic Center – Completed**

 - Health Department – Completed**
 - Public Works – 98% Complete**
 - Sheriff's Office – 88% Complete**

NEXT STEPS

- Purchase additional poles for inventory – place in areas where mobile cameras will be needed.
- Purchase additional cameras for mobile set ups to include:
 - Cameras; battery, and solar panels (\$20K +)
- Place funding in the FY26 Budget for camera placement within various parks i.e. Shirley B. Winston; Psalm Road, Rigdon Park, Lakebottom, Cooper Creek, Flat Rock then additional areas in future budgets.
