Funds will be requested from the Federal Emergency Management Agency to fund the purchase of 26 LIFEPAK 35 cardiac monitors for the Columbus Fire and Emergency Medical Services Department. There is a 10% (\$135,394.73) matching funds requirement.

Background: Funds will be requested from the Federal Emergency Management Agency to fund the purchase of 26 LIFEPAK 35 cardiac monitors for the Columbus Fire and Emergency Medical Services Department. The acquisition of these cardiac monitors will allow the department to replace its cache of LIFEPAK 15 cardiac monitors. This project is critical to ensure that our department remains at the forefront of prehospital emergency care, enhancing our capacity to respond to cardiac and other critical emergencies effectively. The upgrade aligns with our mission to safeguard the health and well-being of our community and ensures compliance with evolving medical standards. This initiative further supports the implementation of the Columbus Correct Care program focused on providing Muscogee County residents the right resources at the right time to support their medical needs for emergency and non-emergency care.

<u>Analysis:</u> Columbus Fire and Emergency Medical Services is requesting funds for the purchase of 26 LIFEPAK 35 cardiac monitors to replace existing LIFEPAK 15 cardiac monitors.

<u>Financial Considerations</u>: The grant is for equipment amounting to a total of \$1,489.341.90, with a 10% matching funds (\$135,394.73) requirement.

<u>Legal Considerations:</u> The Consolidated Government of Columbus is eligible to receive these funds.

WHEREAS, the equipment requested in the grant proposal will be used to replace an existing cardiac monitors within Columbus Fire and Emergency Medical Services; and,

WHEREAS, these devices allow firefighters to track and display a patient's heart activity, providing critical information to firefighters about the cardiovascular system; and

WHEREAS, this grant proposal will require 10% matching funds.
