AGENDA SUBJECT:	Safe Streets and Roads for All (SS4A) Plan – RFP No. 24-0036
INITIATED BY:	Finance Department

It is requested that Council authorize the execution of a contract with Alfred Benesh & Company (Atlanta, GA) to support the creation of a city-wide Safety Action Plan in accordance with Safe Streets and Roads for All SS4A guidelines. The vendor cost proposals is within the amount budgeted for this project.

The SS4A Action Plan will be in accordance with the U. S. Department of Transportation guidelines:

- Safety Analysis
- Public Involvement
- Identification and analysis of underserved communities
- Assessment of current policies, guidelines and standards
- Identification and prioritization of projects and strategies
- Implementation and evaluation of quick-build pilot studies to inform action plan strategies.

To prepare the Safety Action Plan, the vendor shall perform the following tasks:

- Task 1 Project Management
- Task 2 Data Collection
- Task 3 Safety Action Plan Development

RFP Advertisement and Receipt of Proposals:

RFP specifications were posted on the web pages of the Purchasing Division, the Georgia Procurement Registry and DemandStar on June 24, 2024. This RFP has been advertised, opened and evaluated. Seven proposals were received by the due date of July 19, 2024, from the following vendors:

Evaluation Committee:

The proposals were reviewed by the Evaluation Committee, which consisted of one voting member from the METRA/Transportation Department, two voting members from the Engineering Department and two voting members from the Planning Department.

Serving as an alternate voter was one representative from the Planning Department.

Serving as non-voting advisors were one representative from the Planning Department, one representative from the Engineering Department and one representative from the Columbus Police Department.

Recommendation Award:

Benesch, the second highest-firm, is recommended for award for the following reasons:

- Benesch is already part of the project team who is working on the Columbus-Phenix City 2050 Metropolitan Transportation Plan (MTP) Update and the 2024 Congestion Management Plan (CMP) Update.
- Benesh has 1100 employees/20 states Pond is a sub already working on Metropolitan Transportation Plan (MTP)
- Benesch Stakeholder and Public Involvement Management is only handled by one person
- Benesch has done multiple vision zero and SS4A projects.

- Sarasota/Manatee MPO

Benesh embarked on the development of the Destination Zero Safety Action Plan. Destination Zero and the Action Plan that supports its effort that goes beyond identifying strategies to eliminate traffic-related deaths and serious injury in that it focuses to also increase healthy and equitable mobility for all roadway users. Guided by a detailed analysis of the region's crash history, stakeholder and local agency partners, public feedback, and input from elected officials, the Destination Zero Action Plan identified strategic safety focus areas and established a set of implementable action strategies.

- Ocala/Marion County TPO

Serving as a General Planning Consultant, Benesch led several task orders, including the Commitment to Zero Safety Action Plan. Safety has long been a priority of the Ocala Marion TPO and Commitment to Zero is the TPO's call to action to eliminate traffic-related fatalities and serious injuries. It also serves as the Safety Action Plan for this 385,000-person North-Central Florida community. The Action Plan strategies were developed and modeled on the Safe System approach, which acknowledges that traffic-related deaths and serious injuries are preventable and that system designers, operators and users have a shared responsibility to put safety first.

- Hillsborough County TPO

The Hillsborough TPO along with its county and municipal partners adopted Vision Zero and a goal of achieving zero traffic deaths. Benesch evaluated two of the Top 20 High Injury Network corridors and identified a menu of implantable countermeasures focused on eliminating fatal crashes while also improving the overall safety, mobility and livability of the corridors. Benesch identified a range of improvement and planning-level cost estimates to aid in obtaining funding for implementation and facilitated coordination between transportation planning, engineering and law enforcement to ensure that safety is addressed from different aspects.

The City's Procurement Ordinance Article 3-110 (Competitive Sealed Proposals for the procurement of Equipment, Supplies and Professional Services) governs the RFP Process. During the RFP process, there is no formal opening due to the possibility of negotiated components of the proposal. In the event City Council does not approve the recommended offeror, no proposal responses or any negotiated components are made public until after the award of the contract. Therefore, the evaluation results and cost information have been submitted to the City Manager in a separate memo for informational purposes.
