The vendor has agreed to provide the additional trailers for the FY21 bid price of \$5,007.00 per unit, for a total price of \$30,042.00.

The Public Works Department requested the trailers which will be used by Urban Beautification & Forestry Division staff to transport lawn mowers. This is new equipment.
