<b>AGENDA SUMMARY:</b>	Approval is requested by resolution to update the City's Grants Management Policy. Revisions to the current policy are needed in order to ensure compliance with local, state, and federal rules and regulations pertaining to grants administration and oversight. Minor policy revisions include requiring pay plan classifications for all grant funded positions, prohibition of pay supplements using grant funds, and allowing adopted pay increases as approved by Council if grant funding is available.

**Recommendation:** Approval is requested by resolution to update the City's Grants Management Policy.

**Background:** Although the City's current Grants Management Policy was established in accordance with Government Finance Officers Association (GFOA) best practices, minor revisions to the current policy are needed in order to ensure compliance with local, state, and federal rules and/or regulations pertaining to grants administration and oversight. Some of the policy revisions includes requiring pay plan classifications for all grant funded positions, prohibition of pay supplements using grant funds, and allowing adopted pay increases as approved by Council if grant funding is available.

**Analysis:** Grants are an important source of funding for governments, but this funding typically comes with special requirements that each recipient must follow. Such requirements can apply to the general operations of the grant, specific compliance rules, monitoring of other parties that may receive resources from the grants, specific time frame, and specialized reporting requirements.

**Financial Considerations:** The City may become fiscally responsible for the administration of grant programs that fail to meet all of the grant requirements. Revisions to the current policy provides more guidance to staff as it relates to associated operating procedures and personnel policies and processes for all applicable grants.

**Legal Considerations:** Council approval is requested to formally revise this fiscal policy.

**Recommendations/Actions:** Approve a resolution to update the City's Grants Management Policy.
