# FY22 HUD FUNDING SOURCES

Community Development Block Grant (CDBG) - As an entitlement community, the City of Columbus receives an annual share of Federal Community Development Block Grant (CDBG) funds through Congressional appropriation and administered through the U.S. Department of Housing and Urban Development (HUD) for projects that:

- Benefit to low- and moderate- income (LMI) persons or Census Tracts;
- Aid in the prevention or elimination of slums or blight; and
- Meet a need having a particular urgency (referred to as urgent need)

The City's FY2022 CDBG allocation - \$1,672,656

Community Development Block Grant – Corona Virus Round 3 (CDBG-CV3) - The City of Columbus has received funding through the Coronavirus Aid, Relief, and Economic Security Act (CARES Act) from the U.S. Dept. of Housing and Urban Development (HUD) to support critical community services during the COVID-19 Pandemic.

• Funds may be used to cover or reimburse allowable costs to prevent, prepare for, and respond to coronavirus and its impact on local communities through partnerships with non-profit agencies administering programs directly to individuals.

The City's FY2022 CDBG-CV3 allocation - \$1,143,059

Home Investment Partnership Grant (HOME) - As an entitlement community, the City of Columbus receives an annual share of Federal Home Investment Partnership Grant (HOME) funds through Congressional appropriation and administered through the U.S. Department of Housing and Urban Development (HUD) for affordable housing projects that:

- Expanding the supply of decent and affordable housing in the U.S.
- HOME is the largest federal block grant program that provides funding dedicated exclusively to increasing the availability of adequate, affordable housing for low-and very low-income households.

The City's FY2022 HOME allocation - \$986,139

Home Investment Partnership Grant - Reprogramming (HOME-Reprogramming) - HOME Funds originally allocated to an affordable housing initiative during FY21 that are being reprogrammed to be expended in FY22.

- Expanding the supply of decent and affordable housing in the U.S.
- HOME is the largest federal block grant program that provides funding dedicated exclusively to increasing the availability of adequate, affordable housing for low-and very low-income households.
