It is requested that Council approve the purchase of one (1) animal control truck (10,000 GVWR Pickup Ford F-250 with Animal Control Body by Jackson Creek Manufacturing), from Wade Ford (Smyrna, GA), in the amount of \$65,375.75, by Cooperative Purchase via the City of Atlanta, Department of Procurement, Contract #10590-WS for Pickup Trucks.

The vehicle will be used by staff in the daily operations of the Animal Control Division for the transporting of animals. This is a replacement vehicle.

The purchase will be accomplished by Cooperative Purchase via Bid Number 10590-WS, initiated by the City of Atlanta Department of Procurement, whereby Wade Ford was one of the successful vendors contracted to provide Light, Medium and Heavy-Duty Pickup Trucks Group(s): All Groups; Extended Warranty; and Leasing Options for the Department of Fleet Services. The contract, which commenced October 5, 2018, is good through October 4, 2021, with an option to extend under the same terms and conditions for two (2), one (1) year extensions. The bid process utilized by the City of Atlanta Department of Procurement meets the requirements of the City's Procurement Ordinance; additionally, cooperative purchasing is authorized per Article 3-118 of the Procurement Ordinance.
