

**AMENDMENT TO**  
**MEMORANDUM OF AGREEMENT**  
**AMONG the COLUMBUS CONSOLIDATED GOVERNMENT, the**  
**HOUSING AUTHORITY OF COLUMBUS**

**AND THE**  
**GEORGIA STATE HISTORIC PRESERVATION OFFICER**  
**REGARDING THE RAD CONVERSION: ELIZABETH CANTY HOMES,**  
**100 CANTY PLACE, COLUMBUS, MUSCOGEE COUNTY, GEORGIA**  
**(HP-170705-002)**

**WHEREAS**, the Georgia State Historic Preservation Officer (SHPO), Columbus Consolidated Government (CCG), and Housing Authority of Columbus (HACG) executed a Memorandum of Agreement (MOA) for HP-170705-002 on June 12, 2019 (Executed MOA); and

**WHEREAS**, the Undertaking has changed from demolishing three buildings within the Elizabeth Canty Homes Complex to demolishing one building (#704) within the Elizabeth Canty Homes Complex; and

**WHEREAS**, SHPO, CCG, and HACG (Signatories) have consulted with each other and determined that per Stipulation VI in the Executed MOA, the MOA should be amended to reflect this change in the scope of work (SOW) and that due to the reduction in the SOW, the Signatories determined that the proposed mitigation to resolve the adverse effect should be amended; and

**WHEREAS**, the CCG will send a copy of this executed amendment to the Advisory Council on Historic Preservation (ACHP);

**NOW, THEREFORE**, in accordance with Stipulation VI, CCG, HACG, and SHPO agree to amend the Executed MOA as follows:

1. Amend the first Whereas clause so it reads as follows:

**WHEREAS**, the Housing Authority of Columbus (HAGG) plans to carry out the demolition of one building (#704) within the Elizabeth Canty Homes Complex under the U.S. Department of Housing and Urban Development's (HUD) RAD Conversion program pursuant to Section 18 of the U. S. Housing Act of 1937 (Undertaking); and

2. Amend the sixth Whereas clause so it reads as follows:

**WHEREAS**, the undertaking consists of the demolition of one, two-story building containing six

(6) apartments within the Elizabeth Canty Homes Complex located at 100 Canty Place in Columbus, Muscogee County, Georgia; and

3. Insert a new Whereas clause between Whereas clause ten and eleven that reads as follows to document additional public consultation conducted due to the change in scope of work:

**WHEREAS**, CCG has consulted with the public at a public meeting held at the Elizabeth Canty Homes leasing office on August 13, 2020, regarding the change in scope of work and no comments were received regarding effects on historic properties; and

4. Delete Stipulation I
5. All other Stipulations shall be renumbered accordingly.




