It is requested that Council approve the purchase of one (1) grab-all truck (PAC-MAC KB-20) from Pac-Mac, a Division of Hol-Mac Corporation (Bay Springs, MS), in the amount of \$143,500.00, by Cooperative Purchase via Sourcewell Contract #041217-HMC.

The equipment will be used by the Community Services Division, of Public Works, to pick up debris left on the City’s Right of Ways. This is new equipment.

The purchase will be accomplished by Cooperative Purchase via Request for Proposal (RFP) Contract #041217-HMC, initiated by Sourcewell, whereby PacMac, a Division of Hol-Mac Corporation was one of the successful vendors contracted to provide Waste & Recycling Equipment. The contract, which commenced July 7, 2017, is good through July 7, 2021, with an option to renew for a fifth year. Sourcewell is a State of Minnesota local government agency and service cooperative created under the laws of the State of Minnesota (Minnesota Statutes Section 123A.21) that offers cooperative procurement solutions to government entities. Participation is open to federal, state/province, and municipal governmental entities, higher education, K-12 education, nonprofit, tribal government, and other public entities located in the United States and Canada. The RFP process utilized by Sourcewell meets the requirements of the City’s Procurement Ordinance; additionally, Cooperative Purchasing is authorized per Section 3-118 of the Procurement Ordinance.
