AGENDA SUBJECT:	Thirty-Eight (38) 2027 Ford Interceptors for the Police Department – Georgia Statewide Cooperative Contract Purchase

It is requested that Council approve the purchase of thirty-eight (38) 2027 Ford Interceptors from Allan Vigil Ford Lincoln (Morrow, GA) at a unit price of \$47,980.00 and a total cost of \$1,823,240.00. The purchase will be accomplished by Cooperative Purchase via Georgia Statewide Contract #99999-SPD-SPD0000218-0002.

The vehicles will be used by Police Officers for patrol duties.

Georgia Statewide Contract #99999-SPD-SPD0000218-0002 is a cooperative contract whereby Allan Vigil Ford Lincoln is one of the awarded vendors contracted to provide Administrative Vehicles. The term of the contract is good through June 15, 2027. The contract is available for use by any Georgia governmental entity. The City's Procurement Ordinance, Article 9-101, authorizes the use of cooperative purchasing.
