**Poll Watcher form-** This form is designed for poll watchers and precinct managers to ensure uniform practices and procedures throughout the county in 2024 and to ensure all parties are aware of the specific duties and responsibilities.

## Old Business:

- Shirley Winston Election Day Investigation Conclusion- The Director provided copies of the investigation to the Board. Based on the investigative finding, no action will be taken by the Board regarding the continued service of the precinct manager. Administratively, the Board has been advised that the cameras have been replaced in recreation centers by the city. Additionally, processes have been refined to establish accountability for processes in the precinct regarding provisional balloting and official poll watchers.
