Background: In 2002, The Columbus Consolidated Government (CCG) executed a warranty deed to receive the property located at 5013 13th Avenue. In 2005, Columbus Housing Initiative, LLC (CHI), utilized \$25,000 in HUD entitlement funding to acquire the property from the city. The requirements of the Federal funding recorded in the security deed required CHI to construct or rehabilitate improvements on the property within 30 days of the signed purchase contact - which was December 13, 2004, and to complete construction/rehab within 12 months of the purchase contract date.

Additionally, CHI could not make any sale, assignment, conveyance, lease, or other transfer of property without approval from the city. CHI has fulfilled the obligations therein contained in the security deed and the quitclaim deed is a necessary document to formally release CHI of any further obligation.

<u>Analysis:</u> CHI has fulfilled the obligations therein contained in the security deed and the quitclaim deed is a necessary document to formally release CHI of any obligation.

<u>Financial Considerations:</u> There are no further financial considerations.

<u>Legal Considerations:</u> The City Attorney will review all agreements as to form before execution.
