It is requested that Council approve the purchase of bus route signs & poles from Vulcan, Inc./Vulcan Sign Division (Decatur, GA) for the estimated contract value as follows: Year 1 - \$11,514.00, Year 2 - \$12,496.00 and Year 3 - \$13,378.00, and a total estimated contract value of \$37,388.00

METRA Transit System will purchase the items on an 'as needed' basis to replace missing, damaged faded and worn-out bus stop signs and poles along the City's bus routes. Metra Transit System will purchase approximately 200 bus stops signs and poles per year.

The contract term will be for three (3) years.

Bid specifications were posted on DemandStar, the City's website and Georgia Procurement Registry on April 2, 2024. Four (4) bid responses were received on May 1, 2024. This bid has been advertised, opened and reviewed. The bidders were:
