It is requested that Council approve the purchase of two (2) used buses from Rush Truck Centers of Georgia, Inc./DBA Rush Bus Centers (Atlanta, GA) in the total amount of \$53,000; the purchase will be accomplished by cooperative purchase via Georgia Statewide Contract #99999-SPD-G20160601-0003.

The Waste Collection Division currently has two donated school buses, V#11427 & V#11428, which are no longer mechanically cost effective or safe to use for the transportation of inmates. Therefore, the Public Works Department has researched and found the following two used school buses at Rush Bus Sale:

2014 IC CE 48P Activity Bus \$27,000

2014 IC CE 72P Bus \$26,000

Both buses have been inspected and have 50,000 miles or less on the engine. Public Works will convert each bus to accommodate inmates being transported from MCP to various drop off points for Integrated Waste. It is imperative to have appropriate transportation for the inmates. Currently, each waste collection vehicle is going to MCP to pick-up inmates to work on the respective truck. Handling the collection of inmates in this manner hinders the trucks from being on the road by 7:00 a.m. Currently, they are late getting onto the routes, starting between 8:00 a.m.-9:00 a.m. daily, which leads to late turn in or route completion.
