**Background:** GRPA, in partnership with the Atlanta Hawks and the Hawks Foundation are offering GRPA member agencies funding, resources, and opportunities across the state to help serve communities through the game of basketball. Each agency can apply for up to \$2,380.00 (6 agencies per district will be awarded) for needs-based scholarship registration.

**Analysis:** Funding will be used to purchase equipment for the program to include basketballs, coaches whistles, coaches shirts, athletic tape, cones, agility ladders, stop watches, scrimmage vests, and other related equipment.
