It is requested that Council approve the purchase of agricultural chemicals from SiteOne Landscape Supply (Cleveland, OH), by cooperative purchasing via BuyBoard National Purchasing Cooperative contract No. 705-23 and No. 706-23. Parks and Recreation budgets approximately \$55,000.00 annually for the purchase of agricultural chemicals.

SiteOne will be utilized as an alternate source for agricultural chemical purchases for the Park Services Division of the Parks and Recreation Department to maintain ballfields.

The purchases will be accomplished by Cooperative Purchase via Request for Proposal (RFP) #705-23 and #706-23, which were initiated by the BuyBoard National Purchasing Cooperative, whereby SiteOne Landscape Supply was one of the successful vendors contracted to provide Field and Turf Irrigation Products, Landscaping Products, and Specialty Conditioners/Soils per RFP No. 705-23 and Grounds Maintenance Equipment, Parts and Supplies per RFP No. 706-23. The contracts, which both commenced June 1, 2023, are good through May 31, 2024. The contracts available under BuyBoard have been awarded by virtue of a public competitive procurement process compliant with State and Federal statutes. The BuyBoard National Purchasing Cooperative streamlines the purchasing process for schools, municipalities, and other public entities across the nation.
