The Sheriff's Office will use the Food Truck to prepare and serve concessions at various outreach events.

Concession Nation is a registered vendor on Sam.gov to participate in Federal procurement opportunities. The vendor has been awarded several individual contracts per bid opportunities offered via Sam.gov to provide Food Trucks to various branches of the Federal Government. This purchase will be accomplished by Cooperative Purchase via US Marine Corps Contract/Order #KBM26-P-0012/ KBM25-Z-0446. The City's Procurement Ordinance, Article 9-101, authorizes the use of cooperative purchasing.
