It is requested that Council approve the purchase of eight (8) benches and four (4) receptacles from Keystone Ridge Design (Butler, PA), in the amount of \$17,235.00. The purchase will be accomplished by Cooperative Purchasing, utilizing State of Pennsylvania COSTARS Contract #014-054, awarded to Keystone Ridge Designs for the provision of Recreational and Fitness Equipment.

The new benches and receptacles will replace damaged and old equipment in the Broadway pocket parks. This is Phase III of the Historic District Preservation Society’s Bench Project. These new items match those installed in the District during Phase I and Phase II of the project.

The State of Pennsylvania issued IFB COSTARS-14 for Recreational and Fitness Equipment in accordance with proper procurement rules and regulations. Keystone Ridge Design was one of the successful vendors awarded the annual contract, which is good through February 8, 2021. The vendor has agreed to offer pricing to the City under this annual contract. The City is authorized to utilize this contract based on Article 9-101 of the Procurement Ordinance, Cooperative Purchasing Authorized.

The purchase will be accomplished thru public/private partnership with the City making a \$15,000 contribution and the Historic District Preservation Society contributing with donations. Funds are available in the FY21 Budget: General Fund – Miscellaneous – Contingency; 0101 – 590 – 2000- CONT – 9801.
