The vendor provides hot asphalt and general road repair services to include: removing old asphalt, resurfacing roads, asphalt patching, concrete patching, mill asphalt paving and etc., on an "as needed" basis. The services are primarily used by the Public Works and Engineering Departments.

Per Resolution No. 076-19, dated March 12, 2019, Council authorized the execution of a 5-year annual contract with Robinson Paving Company, now The Scruggs Company. The contract expired on April 9, 2024. However, in accordance with Article 3-109 (Annual Contracts: Price Agreement and Service Contracts) of the Procurement Ordinance, and at the request of the Public Works and Engineering Department, the contract was extended for one year, through April 9, 2025.
