AGENDA SUBJECT:	Comprehensive Inmate Healthcare Services for Muscogee County Jail (Annual Contract) – RFP No. 25-0005
INITIATED BY:	Finance Department

It is requested that Council authorize the execution of an annual contract with FirstClass Healthcare, LLC (Atlanta, GA) to provide comprehensive healthcare services for offenders incarcerated at the Muscogee County Jail.

FirstClass Healthcare, LLC, will provide services that conform with all applicable standards, including those established by the National Commission of Correctional Healthcare (NCCHC), and applicable administrative rules of the Muscogee County Jail, to include:

- Health history interview, physicals and dental exams
- Triaging of complaints
- Sick call
- Hospital care (15-bed space medical housing at the Jail)
- Specialty services
- Emergency services
- Ancillary services (make provisions for ambulance services, onsite x-ray providers, prescription drugs, laboratory services, and biohazard disposal/providers)
- Referral arrangements with medical specialists for treatment of issues beyond the scope of the onsite services
- Medical records
- Medical and office supplies
- Pharmaceutical services
- Health education
- Appropriate staffing of medical professionals
- Daily and monthly reports
- Program support services

The initial term of the contract will be for two (2) years with the option to renew for three (3) additional twelve-month periods. Contract renewal will be contingent upon the mutual agreement of the City and the Contractor.

Annual Contract History:

The previous five-year contract was awarded on March 8, 2022 (Resolution No. 070-22) to Wellpath, LLC. The contract initiated on April 1, 2022, and the first term ran through March 31,

2024. The Muscogee County Sheriff determined the needs of the Jail would be best met by advertising a new RFP for these services. Wellpath, LLC, was notified and has agreed to extend the contract through March 31, 2025, to allow for the advertisement of a new RFP.

RFP Advertisement and Receipt of Proposals:

RFP specifications were posted on the web pages of the Purchasing Division, the Georgia Procurement Registry and DemandStar on July 17 2024. This RFP has been advertised, opened and evaluated. Seven (7) proposals were received by the due date of October 25, 2024, from the following vendors:

Evaluation Committee:

The proposals were reviewed by the Evaluation Committee, which consisted of two voting members from the Muscogee County Sheriff's Office and one voting member from the Muscogee County Prison.

Serving as non-voting advisors were one representative from the Muscogee County Sheriff's Office, one representative from the Finance Department and one representative from the City Attorney's Office.

Award Recommendation:

The voting Committee members recommend award to FirstClass Healthcare, LLC (Atlanta, GA) for the following reasons:

• FirstClass Healthcare, LLC

- o This company is within driving distance, which is helpful to the County Jail, and they can handle the inmates currently being held in the jail.
- They focus on operational efficiencies utilizing technology to ensure all needs are met and real-time statistics are available. They also focus on reduced hospital transfers and have robust mental health services available.
- The program support model satisfies the daily operations of the jail. Strengths are there organization structure and diversity in current contracts/sizes of facilities they service.

Oualifications/Experience:

- FirstClass Healthcare is a physician owned and operated healthcare entity.
- FirstClass Healthcare was organized to provide correctional healthcare services in March of 2022. However, they partnered with the Georgia Department of Health as the preferred COVID-19 vaccine and testing provider for prisons, jails, juvenile detention centers, and other confinement-setting facilities throughout the State.
- The managing partners of FirstClass Healthcare are a team of highly experienced professionals, six (6) of whom are licensed medical professionals (three board-certified emergency medicine physicians and three board-certified physician assistants).
- The managing partners collectively have over sixty (60) years of experience in clinical operations in large urban healthcare systems including the Emory Healthcare System, Grady Memorial Hospital, the VA Medical Center and the Orlando Health System.
