AGENDA SUBJECT:	Single Stream Recycling Materials Processing (Re-Bid) (Annual Contract) – RFP No. 25-0013
INITIATED BY:	Finance Department

It is requested that Council authorize the execution of a contract with Federal Recycling and Waste Solutions (St. Louis, MO) for single stream recycling materials processing.

The vendor will receive recycling materials, delivered by Public Works collection vehicles, and serve as a processor as well as an end market for recycling materials. The City will receive a rebate based on the recycling material that is useable.

### **RFP Advertisement and Receipt of Proposals:**

RFP specifications were posted on the web page of the Purchasing Division, the Georgia Procurement Registry and DemandStar on September 6, 2024. No proposals were received on the due date of October 4, 2024. In accordance with Section 3-108, Item H of the Procurement Ordinance, the Purchasing Division performed due diligence by conducting a survey of non-responsive firms to determine if it was necessary to revise the specifications to encourage more competition.

The following five (5) vendors were surveyed:

- 1. 121 Disposal No Response.
- 2. Amwaste No Response.
- 3. Federal Recycling and Waste Solutions Vendor responded that they did not have pricing ready by the time the proposal was due, but expressed interest in submitting a proposal.
- 4. GFL Vendor does not offer single stream recycling.
- 5. Southeast Recycling Technologies No response.

Based on the response from Federal Recycling, and to increase competition, the RFP was readvertised on November 14, 2024, as RFP No. 25-0013; Single Stream Recycling Materials Processing (Re-Bid) (Annual Contract).

One proposal was received on the due date of December 20, 2024. The sole responding vendor was:

### Federal Recycling and Waste Solutions (Columbus, GA)

This RFP has been advertised, opened, and evaluated.

# **Evaluation Committee:**

The voting committee members consisted of two representatives from the Public Works Department and one representative from the Information Technology Department.

The voting members representing Public Works also served as Advisors.

# **Award Recommendation:**

Based on the results of the evaluation ballots, the voting committee members unanimously recommended award to the sole vendor, Federal Recycling and Waste Solutions for the

## following reasons:

- It's a significant advantage that the vendor already services the Columbus area and has the capacity to receive over 1,000 additional tons of single stream material per month.
- The vendor appears to be very accommodating in that they have identified a space solely for CCG recycling and, if that is not a sufficient location, they have identified one additional acre to be used by the City.
- Federal Recycling and Waste Solutions is a forward thinking recycling service that helps operations build more profitable and sustainable operations.
