**Background:** The PY25 / FY26 Annual Action Plan was approved on April 8, 2025, by City Council via Resolution 111-25. A typographical error has been identified in the title of the resolution, which references the FY24 Annual Action Plan instead of the FY26 Annual Action Plan.

**Analysis:** The resolution title should be amended to state “FY26 Annual Action Plan” for accurate record keeping.

**Financial Considerations:** None.

**Legal Considerations:** The amended resolution will be filed with all Community Development Block Grant (CDBG) Program, the HOME Investment Partnership Program (HOME), and the Emergency Solutions Grant (ESG) Program sub-recipient agreements and contracts funded from FY26 HUD grants. Unobligated funding from FY26 will reference the amended resolution approved by the council.
