A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR, ACCEPT, AND EXPEND ANY AWARDED FUNDS AS PER THE GRANT GUIDELINES AND CITY REGULATIONS, IF AWARDED, A GRANT OF \$500,000.00, OR AS OTHERWISE AWARDED, FROM THE U.S. DEPARTMENT OF JUSTICE OFFICE OF COMMUNITY ORIENTED POLICING SERVICES, FY25 SAFER OUTCOMES: ENHANCING DE-ESCALATION AND CRISIS RESPONSE TRAINING FOR LAW ENFORCEMENT – SUPPORT FOR LAW ENFORCEMENT AGENCIES GRANT, WITH NO LOCAL MATCH REQUIREMENT, AND TO AMEND THE MULTI-GOVERNMENTAL FUND BY THE AMOUNT AWARDED. FUNDS WILL BE UTILIZED TO PROMOTE SAFE OUTCOMES DURING POLICE ENCOUNTERS WITH PERSONS IN CRISIS THROUGH RELEVANT TRAINING.

**WHEREAS,** the Muscogee County Sheriff's Office has been authorized by the U.S. Department of Justice Office of Community Oriented Policing Services. to apply for \$500,000.00 of grant monies; and,

**WHEREAS**, funding is from the U.S. Department of Justice Office of Community Oriented Policing Services - FY25 Safer Outcomes: Enhancing De-Escalation and Crisis Response Training For Law Enforcement – Support for Law Enforcement Agencies Grant application; and,

**WHEREAS**, funds will be utilized to promote safe outcomes during police encounters with persons in crisis through relevant training; and,

**WHEREAS**, funding will provide state, local, territorial, and tribal law enforcement agencies with the resources they need to secure, deliver, and assess quality de-escalation and crisis response training; and,

**WHEREAS,** for purposes of this funding opportunity, the term "de-escalation" means taking action or communicating verbally or non-verbally during a potential force encounter in an attempt to stabilize the situation and reduce the immediacy of the threat so that more time, options, and resources can be called upon to resolve the situation without the use of force or with a reduction in the force necessary.; and,
