It is requested that Council approve the purchase of a RescueOne Connector Boat® from RescueOne Connector Boats/Marine One Corporation, (Southside, AL) in the amount of \$57,950.00, plus applicable delivery costs. The purchase will be partially funded by OLOST funds reallocation.

Columbus Fire and EMS serves as the only water rescue team in the area and the Columbus Fire and EMS Water Rescue Team is in desperate need of rescue boats. The current boats are over 15 years old and have served their purpose. These boats and wave runners are not capable of being frontline equipment anymore and will be used as backup equipment if approved to purchase new equipment. The Department is concerned that responses to water rescue calls will not be adequately accomplished with the current equipment.

The RescueOne Connector Boat® is a one-of-a-kind boat that can be used as a rescue/recovery boat in deep water or can be used in water as deep as one foot in flood instances. The boat supports rescue divers and their gear without sacrificing safety. The Diver Support/ Victim Lift is a tool that would be used often due to the number of rescue/recoveries that Columbus Fire and EMS responds to annually. Lastly, the Helix Hummingbird Side Scan Sonar System allows the water team to search underwater for items or victims before deploying divers which is a huge safety concern.
