AGENDA SUBJECT:	Stretcher Preventative Maintenance for Fire & EMS (Annual Contract) – RFP No. 22-0029
INITIATED BY:	Finance Department

It is requested that Council approve the execution of an annual contract with Stryker Sales, LLC (Portage, MI) to provide stretcher preventative maintenance services and for the purchase of stretcher accessories, for the Columbus Fire & EMS Department, for the estimated annual contract value of \$23,412.00.

The Contractor shall furnish all parts, labor and travel for the stretcher annual preventative maintenance inspection. The stretcher equipment includes power cots, manual cots, power load systems and stair chairs. Stretcher accessories include power cot batteries, mattresses, safety belts, side rails, IV poles and oxygen bottle holders.

The initial contract period will be for two (2) years, with the option to renew for three (3) additional twelvemonth periods. The Contract renewal will be contingent upon the mutual agreement of the City and the Contractor.

Bid specifications were posted on the web page of DemandStar, the Purchasing Division, and the Georgia Procurement Registry. The original bid was due March 2, 2022 with no bids received. The Purchasing Division performed due diligence by contacting multiple vendors to encourage a bid. Consequently, the bid due date was extended to March 23, 2022. One (1) bid was received from Stryker Sales, LLC (Portage, MI) who sells and services the Stryker brand stretcher equipment currently utilized by Columbus Fire & EMS. Only a Stryker dealer is approved to maintain this equipment.
