AGENDA SUBJECT:	Inmate Food Service Management for Muscogee County Jail (Annual Contract) – RFP No. 21-0036
INITIATED BY:	Finance Department

It is requested that Council authorize the execution of an annual contract with Skillet Kitchen (LaGrange, GA) for inmate food service management at Muscogee County Jail. The recommended vendor's cost proposal is within budget.

Skillet Kitchen will be responsible for the following:

- Inmate food service management that includes, but is not limited to providing all required labor, food, beverages, materials, supplies and chemicals necessary for the inmates and staff at Muscogee County Jail.
- Providing food service preparation in the kitchen of the facility.
- Serving from a twenty-eight (28) day cycle menu, at proper temperature, nutritious, wholesome, palatable meals and special diets to the inmates, staff and designated visitors of Muscogee County Jail.
- Providing meals and food service three (3) times per day, seven (7) days per week at the Jail.
- Managing a civilian and inmate kitchen staff, which shall prepare pre-plated meals for service on trays, for delivery to Correctional Officers at designated areas. The Correctional Officers will verify meal counts and supervise inmates who will distribute trays to other inmates, in a timely and sanitary manner, in living areas.
- Using USDA Grade A or Grade B food, without any pork product or pork derivatives.

The term of the contract will be for two (2) years with the option to renew for three (3) additional twelve-month periods. Contract renewal will be contingent upon the mutual agreement of the City and the Contractor.

Annual Contract History:

The previous 5-year contract was awarded to Aramark Correctional Services, LLC on June 9, 2020, per Resolution No. 145-20. The Muscogee County Sheriff's Office chose to cancel the contract and issue a new RFP for the services.

<u>RFP</u> Advertisement and Receipt of Proposals:

RFP specifications were posted on the web page of the Purchasing Division, the Georgia Procurement Registry and DemandStar on April 8, 2021. This RFP has been advertised, opened, and evaluated. Three proposals were received on May 7, 2021, from the following:

Skillet Kitchen (LaGrange, GA)

Trinity Services Group, Inc. (Oldsmar, FL) Aramark Correctional Services, LLC (Philadelphia, PA)

Evaluation Committee:

The proposals were reviewed by members of the Evaluation Committee, which consisted of two voting members from the Muscogee County Sheriff's Office and one voting member from the Clerk of Superior Court's office.

A representative from the Clerk of Municipal Court's Office and a retiree of Muscogee County Prison served as alternate voters.

An additional representative from the Muscogee County Sheriff's Office served as a non-voting advisor.

Award Recommendation:

Based on the final evaluation ballots results, the Committee unanimously recommends award to Skillet Kitchen.

Vendor Qualifications/Experience:

- Skillet Kitchen is a division of Kimble's Food by Design, which is a privately owned company that has been in business since 1985 and has served correctional institutions housing over 500 inmates
 since
- Kimble's Food by Design employs approximately 290 associates; 103 of those associates are assigned to Skillet Kitchen.
- Skillet Kitchen employs associates with over 200 years of corrections and law enforcement experience collectively and has associates on staff with many years of experience in the correctional food service industry.
- Kimble's Food by Design also provides commissary services, vending services and cornflake chewy candy.

The City's Procurement Ordinance, Article 3-110, (Competitive Sealed Proposals (Negotiations) governs the RFP Process. During the RFP process, there is no formal opening due to the possibility of negotiated components of the proposal. In the event City Council does not approve the recommended offeror, no proposal responses or any negotiated components are made public until after the award of the contract. Therefore, the evaluation results and cost information has been submitted to the City Manager in a separate memo for informational purposes.

A RESOLUTION AUTHORIZING THE EXECUTION OF AN ANNUAL CONTRACT WITH SKILLET KITCHEN (LAGRANGE, GA) FOR INMATE FOOD SERVICE MANAGEMENT AT MUSCOGEE COUNTY JAIL. THE RECOMMENDED VENDOR'S COST PROPOSAL IS WITHIN BUDGET.

WHEREAS, an RFP was administered (RFP No. 21-0036) and three proposals were received; and,

WHEREAS, the proposal submitted by Skillet Kitchen (LaGrange, GA) met all proposal requirements and was evaluated most responsive to the RFP; and,

WHEREAS, the contract period shall be for two years, with the option to renew for three additional twelve-month periods. Contract renewal is contingent upon the mutual agreement of the City and the Contractor.
