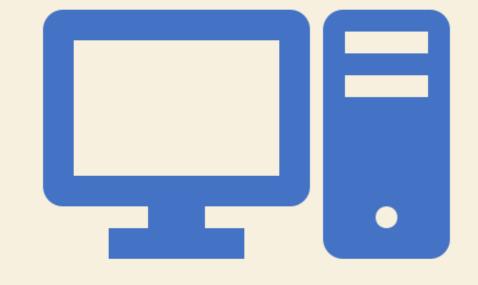

RANSOMWARE UPDATE

- On Tuesday, May 26th at approximately 7:00 p.m. a ransomware event was initiated on the CCG network.
- Preliminary investigation suggests that the event was initiated on a vendor managed system.
- Within approximately 30 minutes Information Technology shut down the attack location.
- Approximately 40 computers and four systems were affected.
- One of the three systems affected was iasWorld to include the public facing website.
- In abundance of caution; all computers in the affected location have been replaced.
- The four systems affected have been placed back online, are in the process of being moved to a cloud solution or are being rebuilt (iasWorld public facing website) from scratch for precautionary reasons.

RANSOMWARE UPDATE

- In a call with the FBI, the security agent commended CCG on containing and mitigating the event.
- MS-ISAC, a federally sponsored cybersecurity agency, was also consulted.
- Engaged existing vendor partners to review our security procedures.
- Continue to run security appliances to scan the network.
- A full report is expected to be completed at the end of July.

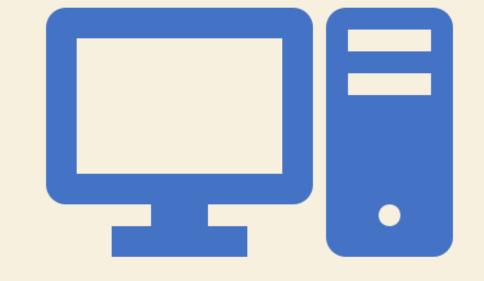
REMOTE WORKFORCE

- When appropriate:
 - The Mayor's Office and the City Manager's Office has been working remotely.
 - Council meetings have been held remotely and livestreamed.
 - Budget hearings have been held remotely.
 - Courts are livestreaming Jail Pleas.
 - Many departments are working remotely.
- During the pandemic, all departments have remained operational.
- The biggest challenge for non-IT staff is the learning curve of using new technology.
- Information Technology's biggest challenge is the ineffective staffing model due to the Mainframe.

LEGACY SYSTEMS MIGRATIONS

- Moving forward with decommissioning legacy systems such as the court/public safety systems currently on the Mainframe.
- The Mainframe, as discussed in previous presentations, moves out of regular warranty on July 1, 2020.
- IT has been put notice; we are only eligible for an IBM partner limited warranty for six additional months.
- It is very important that the Mainframe court systems move to the new court/public safety management systems; to include Odyssey, Eagle Recorder, Civil Serve and E-citation because of the announced end of life of Mainframe, maintenance and the inability to license.
- The new court/public safety systems are expected to be live this fall.
