

3. Pursuant to O.C.G.A. 17-5-54 (a)(1), these items "cannot be returned to the proper owner(s) because the owner(s) cannot be located, the owner(s) cannot identify the items, or the property was found and not claimed."
4. The listed items have been in the custody of the Columbus Police Department for over 90 days and said items are no longer needed for any investigatory or evidentiary purposes.
5. Therefore, pursuant to O.C.G.A. 17-5-54(e), Applicant requests that this Court issue an Order authorizing the items to be sold at city auction.

6. The authorization of these items has been approved by the Chief of Police.
7. If the Order sought is granted by this Court, the items will be sold at the city auction. The city surplus auction will take place within 30 days of the signed court order at the Civic Center, 400 4th Street Columbus, Georgia. Evan Auctioneers will be conducting the city surplus auction.



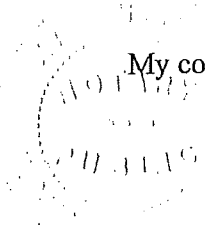
