AGENDA SUBJECT:	Encroachment Agreement - Whitesville Road and Maplebrook Drive
AGENDA SUMMARY:	Approval is requested authorizing the execution of an Encroachment Agreement for the construction of a private sanitary sewer within the right of way of Whitesville Road and Maplebrook Drive.

**Recommendation:** Approval is requested authorizing the execution of an Encroachment Agreement for the construction of a private sanitary sewer force main within the west right of way along Whitesville Road and along the south right of way line of Maplebrook Drive.

<u>Background:</u> The Department of Engineering has received a request from Harvest Pointe Church of the Nazarene, owner of property at 7777 Whitesville Road, to construct a 2 "sanitary sewer force main on the City right of way. The pipe is proposed to run north along the west right of way line for Whitesville Road and run along the southern right of way line of Maplebrook Drive to discharge into an existing manhole near 1436 Maplebrook Drive that is maintained by the Columbus Water Works. CWW has agreed to allow the sewer to be discharged into the existing manhole.

<u>Analysis:</u> A concept drawing is attached showing the proposed improvements. An engineered drawing will be provided to the Department of Engineering at the time of permitting. The City has authorized this type of permanent encroachment in the past. The agreement allows for the construction, repair and maintenance of the private sanitary system. The owner understands the risk of installing a private sewer on the right of way and possibility of damage from utilities or others. It is recommended that the Church provide identification markers to warn utilities and others of the location of the private sewer.

**<u>Financial Considerations</u>**: There are no financial obligations for the City.

<u>Legal Considerations:</u> Council must approve all permanent encroachments onto public property.

**Recommendation/Action:** Approval is requested authorizing the execution of an Encroachment Agreement for the construction of a private sanitary sewer force main within the west right of way along Whitesville Road and along the south right of way line of Maplebrook Drive.
