Hearing and eye protection equipment is needed for all sworn officers while using the firing range. The Police Department currently has a small supply of hearing and eye protective equipment that is shared by personnel. To ensure the reduction of the spread of COVID-19, germs or other viruses, each officer will be issued their own hearing and eye protective equipment as part of their standard issue of gear. The hearing protective equipment is equipped with microphones which will allow the user to hear instructions from the Range Officers or other conversation, while simultaneously protecting their hearing from weapons being fired. The eye protective equipment will not only protect them from bullet projectiles, but also airborne droplets from germs and viruses.
