AGENDA SUBJECT:	Elections and Registration grant for runoff election
AGENDA SUMMARY:	Approval is requested to accept an award from the Center for Tech and Civic Life in the amount of \$312,495, or as otherwise awarded, for personnel, equipment and supplies, and facility rental and cleaning to help the Elections and Registration respond to needs arising as a result of COVID-19 in the upcoming Georgia Senate runoff election, and amend the Multi-governmental Fund by the amount awarded. There are no local match funds required.

**<u>Recommendation</u>**: Approval is requested to apply for and accept an award from the Center for Tech and Civic Life, a 501(c)3 nonprofit organization, in the amount of \$312,495, or as otherwise awarded, for personnel, equipment and supplies, and facility rental and cleaning to help the Elections and Registration respond to needs arising as a result of COVID-19 in the upcoming Georgia Senate runoff election, and amend the Multi-governmental Fund by the amount awarded. There are no local match funds required.

**Background:** Funds are being made available to help the Muscogee County Elections and Registration office deal with the effects of COVID-19 during the various elections being held this year.

Analysis: The November 3 General Election resulted in a runoff election required for both U.S. Senate seats for the State of Georgia. The June 9, 2020 General primary saw a 420% increase in the number of absentee applications processed and ballots received and counted. The county struggled to provide a safe environment for early voting workers, poll workers, elections staff and voters. Additionally, we faced a time of community unrest and had to staff early tabulation, early voting, and preparation of election equipment during peaceful protests outside the government building that houses elections operations. For the runoff election, as was the case with the General Election, the number of total registered voters is expected to be between 135,00 and 140,000. Plans are being made with the expectation of a 90% turnout or 126,000 voters casting ballots either in person or by absentee ballot. The desire is to deliver a smooth and positive voting experience but meeting this challenge will require a collaborative effort as well as additional funding. An executive order issued by the Governor of the state limits the number of people that can gather in a public place which limit will limit access to the voting process and the need to mitigate wait times by providing alternatives. Each additional alternative will require more resources in an increasingly competitive environment. This document offers an assessment of resources needed for Muscogee County to prepare for the general election safely and thoroughly.

**Financial Considerations:** The City will incur no financial obligations as a result of this grant. There is no local match requirement.

**Legal Considerations:** The City is eligible to receive this grant award. If accepted, the City will be obligated to abide by the terms of the grant contract.

**<u>Recommendation/Action</u>**: Authorize the application for and acceptance of a grant award from the Center for Tech and Civic Life in the amount of \$312,495, or as otherwise awarded, with no local match required, for Elections and Registration, and amend the Multi-governmental Fund by the amount awarded.
