**Recommendation:** Approval is requested to enter into a Memorandum of Understanding with the Medical Center, Inc. d/b/a Piedmont Columbus Regional Midtown in order to meet the eligibility requirements to buy discounted outpatient drugs under Section 340B of the Public Health Services Act.

**Background:** The contract for Indigent Medical Care with The Medical Center Hospital Authority of Columbus, Georgia expires on June 30, 2022. In order for Piedmont Columbus Regional Midtown to continue to utilize the 340B prescription program to provide discounted drugs to indigent persons, an agreement must be in place effective July 1, 2022.

<u>Analysis:</u> Piedmont Columbus Regional Midtown is committed to providing services to indigent persons who are not covered by Medicare, Medicaid or other insurance regardless of their ability to pay. The Section 340B program of the Public Health Services Act requires a private non-profit disproportionate hospital to have a formal agreement with the local government to participate in the program. The Indigent Medical Care contract has been utilized in the past to meet this requirement.

<u>Financial Considerations</u>: There are no financial obligations to the Columbus Consolidated Government.

<u>Legal Considerations:</u> There is no legal issue with accepting this unilateral commitment on the part of Columbus Regional Midtown as it does not prevent other efforts of the City to contract for the provision of indigent medical care.

**Recommendation/Action:** Approval is requested to enter into a Memorandum of Understanding with the Medical Center, Inc. d/b/a Piedmont Columbus Regional Midtown in order to meet the eligibility requirements to buy discounted outpatient drugs under Section 340B of the Public Health Services Act.

**WHEREAS**, in order for PCRM to continue to qualify for discounted outpatient drugs under Section 340B of the Public Health Services Act, an agreement with the local government is required; and,

**WHEREAS**, the MOU does not require any exclusive or financial commitment from the City of Columbus.

## NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF COLUMBUS, GEORGIA, AS FOLLOWS:

That the City Manager is authorized to enter into a Memorandum of Understanding with the Medical Center, Inc. d/b/a Piedmont Columbus Regional Midtown accepting its commitment to provide indigent care services under Section 340 of the Public Health Services Act for the initial period of one year from July 1, 2022 to June 30, 2023 with for additional one-year renewals upon mutual written agreement by both parties.
