Recommendation: Approval is requested to update the custodial account with Valic/AIG vendor for the 457 Deferred Compensation Plan for the benefit of employees and their beneficiaries.

Background: In April 2016 Valic/AIG became the sole 457 Deferred Comp Plan provider for new accounts. With Resolution #119-16 Council authorized establishing a custodial account with Valic/AIG Federal Savings Bank. The Plan Sponsor, Columbus Consolidated Government, further authorized individuals holding certain positions with the Plan Sponsor to act on behalf of the Plan.

<u>Analysis:</u> The Plan Sponsor desires to update authorized individuals holding certain positions with the Plan Sponsor to act on behalf of the Plan related to Valic/AIG's custodial account.

<u>Financial Considerations:</u> There is no financial impact to the Plan Sponsor, Columbus Consolidated Government, or employees and their beneficiaries.

<u>Legal Considerations:</u> The Council must authorize an update to the individuals authorized to access the custodial account with Valic/AIG Federal Savings Bank.

Recommendation: The Human Resources Director and Finance Director recommend the proposed resolution.
