The work includes providing all labor, equipment and materials to remove the existing roof and replace with a new asphalt shingle system.

Specifications were posted on the web page of the Purchasing Division and on the Georgia Procurement Registry on November 7, 2019. A mandatory site visit was held on November 19, 2019; six (6) contractors were represented at the site visit. Five (5) bids were received on December 11, 2019. The bidders were:
