**Council Districting Commission:** The commission is responsible for the city's redistricting plan. Upon completion of the United States 2020 census, all local governments in Georgia would draft and enact new district maps; district lines are redrawn every 10 years. Federal law stipulates that elective districts must be apportioned with nearly equal populations and must not discriminate on the basis of race or ethnicity.

Enclosed for your review are the (32) thirty-two names received in the Clerk of Council's Office on April 2, 2021 from the Muscogee County Grand Jury for your consideration. Each District Councilor will select one nominee from your respective Council District, as well as, the Mayor would select one nominee from each of the eight districts from the same listing. This would equate to sixteen (16) members with the Probate Court Judge serving as the ex-officio member.


