<u>Recommendation:</u> Approval is requested for the acceptance of that portion of Lemongrass Drive and that portion of Morning Dew Drive located in Section Two, Courtland Ridge.

<u>Background</u>. That portion of Lemongrass Drive and that portion of Morning Dew Drive located in Section Two, Courtland Ridge, has forty-three (43) residential lots. The streets have been improved and meet the required specifications for acceptance by the City.

<u>Analysis:</u> A deed has been conveyed to the City Those certain tracts or parcels of land designated as that certain extension of Lemongrass Drive, and that certain extension of Morning Dew Drive, lying and being in Columbus, Muscogee County, Georgia, designated as that portion of Lemongrass Drive, and that certain portion of Morning Dew Drive as shown upon a map or plat of survey entitled "Section Two, Courtland Ridge of Land Lot 42, 9th District, Columbus, Muscogee County, Georgia," prepared by Moon Meeks & Associates, Inc., dated August 6, 2025 and recorded in Plat Book 168, Page 113, in the Office of the Clerk of Superior Court of Muscogee County, Georgia.

<u>Financial Considerations</u>: No City funds are involved until maintenance is assumed after the two-year warranty.

<u>Legal Considerations:</u> In accordance with Section 18-3 of the Columbus Code, all dedicated right-of-way must be accepted by Council.

Recommendation/Action: Approval is requested for the acceptance of that portion of Lemongrass Drive and that portion of Morning Dew Drive located in Section Two, Courtland Ridge.
