It is requested that Council approve the purchase of One (1) 2026 F-350 Crew Cab Flatbed for Public Works from Wade Ford (Smyrna, GA) in the amount of \$70,974.00. The purchase will be accomplished by cooperative purchase via Georgia State #99999-SPD-SPD0000155-0006.

The vehicle will be used by Public Works to remove trash and debris along the City right-a-way. The vehicle is a replacement.

Georgia Statewide Contract #99999-SPD-SPD0000155-0006 is a cooperative contract whereby Wade Ford is one of the awarded vendors contracted to provide Truck Chassis and Truck Bodies. The term of the contract is good through August 31, 2026. The contract is available the use by any Georgia Government entity. The City's Procurement Ordinance, Article 9-101, authorizes the uses of cooperative purchasing.
