<u>Background:</u> The Columbus Police Department has recently expanded its Special Operations Unit with the addition of a four-man K-9 Unit. These highly trained K-9s play a vital role in supporting law enforcement efforts, often working in high-risk situations. The addition of protective vests will be an invaluable asset in ensuring the safety of these K-9s as they face potentially dangerous encounters in the field.

<u>Analysis:</u> The Columbus Police Department is committed to the care and maintenance of the newly donated vests and will ensure they remain secure and in optimal condition at all times.

<u>Financial Considerations</u>: The donated vests are specifically for the Columbus Police Department's K9 Unit and will be at no cost to the Columbus Consolidated Government.
