Recommendation: Approval is requested for the Mayor, or his designee to apply for and accept, if awarded, the Homeland Security grant award, in the amount of \$30,000.00, or as otherwise awarded, for the purchase of 240 CERT kits (equipment) for the Community Emergency Response Team program to train citizens in emergency preparedness and how to respond to emergencies in their homes and work places until first responders can arrive, with a local match requirement of \$7,500.00, and amend the multi-governmental fund by the amount awarded.

<u>Background:</u> Columbus Homeland Security and Emergency Management has revitalized the Community Emergency Response Team training program to help train citizens on how to respond to emergencies and disasters at work, at home, and in other places. This program was designed to train citizens to be able to take care of themselves and their neighbors until first responders and other help arrive. This grant will provide funding for over 240 CERT kits that can be distributed to citizens who successfully complete the 16-hour or more CERT program and demonstrate their ability to apply the training during emergencies and disasters.

<u>Analysis:</u> This purchase needs the support of state homeland security funds. This equipment would be used in Muscogee County and be deployable to mutual aid partners as well.

<u>Financial Considerations</u>: This is not a budgeted item, and the 25% match would need to be budgeted once the application is approved.

<u>Legal Considerations:</u> Council approval is needed to apply for and accept, if awarded, the State Homeland Security grant, and to amend the multi-governmental fund by the amount awarded.
