**Recommendation:** Approve the acceptance of that portion of Holstein Hill located in Phase Three, Section One, Heiferhorn Farms.

**Background**. That portion of Holstein Hill located in Phase Three, Section One, Heiferhorn Farms has (17) Seventeen residential lots. The street has been improved and meets the required specifications for acceptance by the City.

Analysis: A deed has been conveyed to the City of all of Holstein Hill lying in Land Lot 227, 19<sup>th</sup> District, Columbus, Muscogee County, Georgia. The above described roads and rights-of-way are shown on the map or plat entitled "Final Plat for Phase Three, Section One, Heiferhorn Farms, Part of Land Lot 227, 19<sup>th</sup> District, Columbus, Muscogee County, Georgia," dated August 26, 2025, made by Strozier" Services LLC and recorded in Plat Book 168, Page 118, in the Office of the Clerk of Superior Court of Muscogee County, Georgia.

**<u>Financial Considerations</u>**: No City funds are involved until maintenance is assumed after the two-year warranty.

<u>Legal Considerations:</u> In accordance with Section 18-3 of the Columbus Code, all dedicated right-of-way must be accepted by Council.

**Recommendation/Action:** Approve the acceptance of that portion of Holstein Hill located in Phase Three, Section One, Heiferhorn Farms.
