#### **NEW BUSINESS**

2. Ambulance Operations Center Update- DISCUSSION ITEM

East Valley site has been secured, possible April/May 2025 occupancy. High Desert and West Valley are still unsecured. Alternate plans are being developed until sites can be secured.

3. Policy and Procedure manual – **DISCUSSION ITEM** *Still in development.* 

4. Staffing Update – **DISCUSSION ITEM** 

CONFIRE currently has 3 positions in process – Purchaser Buyer, MIS Director, and (3) System Status Controllers are in background.

Priority – (2) Ops managers and (1) DQA (Document Quality Assurance Manager) still need to be filled.

We anticipate having an over staffed ambulance crew come October 1<sup>st</sup>.

5. CFAA Admin. Rate – **DISCUSSION ITEM** 

Thru the process and currently working with Kaiser.

6. Vehicle Production Update – **DISCUSSION ITEM** 

All staff vehicles except 1 have been received.

Ambulance count is currently 85 and looking good. Fifteen type 3 F450 units also received. Our peak deployment is 104 and should easily be met. All units are brand new, the need for reserves should be little to none.

## 7. ICEMA Transport Agreement Update – **DISCUSSION ITEM**

We are currently approved to transport in non EOA areas, an item will go before the County Board of Supervisors in September which will authorize us to transport EOA effective October 1, 2024.

### 8. Technology Update – **DISCUSSION ITEM**

Ipads have been delivered and Priority IT has been busy updating them. All mobiles and portables have been received, employees are working on the programming and installation. We are looking at being logistically ready as of Sept. 1<sup>st</sup>.

# 9. Agency Agreement Update - DISCUSSION ITEM

We are actively working with public ambulance companies/agencies to have contracts in place.

## 10. CAD to CAD Update – **DISCUSSION ITEM**

Still in the testing phase, actual data is going back and forth. Chief Mike Wedell should have an update shortly.
