MINUTES

PLEDGE OF ALLEGIANCE

Commissioner Green opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance.

ROLL CALL

Present were Commissioners Mallozzi, Katzman, Shrouder and Green. Mayor Ross was present via Zoom.

DECORUM

City Attorney Horowitz read the decorum policy as follows: Members of the Commission, staff members, citizens, and others are required to use civil and appropriate language when addressing the Commission or anyone present at the meeting and must refrain from using profanity, cursing, or exhibiting aggressive or threatening behavior. All comments should generally be directed to the presiding officer and not to individual members of the Commission, staff, or the audience. No personal verbal attacks toward any individual by either the Commission, staff, citizens, or others shall be allowed during any meeting of the Commission. Any persons making impertinent or slanderous remarks or personal attacks or who becomes boisterous while addressing the Commission or who otherwise violates the decorum rules set forth herein shall be barred from further audience before the Commission by the Mayor, or by request of any member of the Commission unless permission to continue or again address the Commission be granted by a majority vote of the Commission members present.

Interim City Manager Carlos Vega asked to defer item 18 to the next Regular City Commission meeting.

Commissioner Katzman advised one of 36 children in the United States has Autism. Approximately two years ago a young man named Andrew Grub introduced him to Dr. Larry Rothman from the organization HAAPE. He spoke to Dr. Rothman and then met with previous City Manager Joseph Napoli who designated Parks and Recreation Director Stacie Weiss the lead on the initiative. He thanked Director Weiss for heading the initiative alongside UN-NSU-CARD. The designation will help the City tremendously.

University of Miami-Nova Southeastern University Center for Autism & Related Disabilities, UM-NSU CARD presented the City with the Autism-Friendly City designation.

MOTION: Commissioner Green moved to approve the Consent Agenda. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (5-0)

REGULAR AGENDA

16. Motion to appoint a Director, Alternate, and Second Alternate to the Broward League of Cities Board of Directors. – Commission

Mayor Ross moved to approve Commissioner Katzman as Director to the Broward League of Cities Board of Directors, Commissioner Shrouder as Alternate and Commissioner Green as Second Alternate.

Commissioner Mallozzi seconded the motion.

Commissioner Green would like Commissioner Mallozzi to serve in his place as second alternate.

Commissioner Mallozzi withdrew the second to the Motion.

No second. The motion died.

MOTION: Commissioner Green moved to approve Commissioner Katzman as Director to the Broward League of Cities Board of Directors, Commissioner Shrouder as Alternate and Commissioner Mallozzi as Second Alternate. Commissioner Mallozzi seconded the motion which prevailed by a unanimous roll call vote. (5-0)

17. Discussion and possible action regarding the usage of Flamingo West Park – Commissioner Mallozzi

Mayor Ross advised it is difficult to discuss an item when no backup is provided.

Commissioner Mallozzi spoke on an instance last week when coaching her team at Flamingo West Park where she witnessed a gentleman doing exercises that causes damage to the field. She advised him of the potential damage and he replied he is being paid to train the children and has done so for two years. She would like the resolution to be amended to remove groups of 20 or less are not required to have a permit. She advised the individuals using the fields are not taking care of the fields and leaving garbage behind. She spoke on a leisure pass that has been utilized in the past. She would also like a one point entry to the park to limit the access to individuals with a pass.

Mayor Ross cannot speak on the item because this is not the proper process. There is no backup provided for a discussion.

Commissioner Mallozzi did not want to have staff work on an option without Commission consensus.

Commissioner Katzman said staff works hard to regulate and take care of the fields. It is also hard to monitor use and he is in favor of the City Manager working on a process to better monitor use of the fields.

Commissioner Green said he has witnessed the same issues and there is a need for staff to provide alternatives.

Commissioner Shrouder said staff should have the rules and regulations codified in writing. He also believes scheduling was already codified. Priority is given to our partner the Optimist, next would be individuals who obtained a permit and lastly open play. He is okay revising procedures to assure the fields are being used by the residents and not for commercial purposes. He does not agree with the single point of entry as that may lead to the need for additional staffing. He would like staff to determine who would handle issues when the Park Ranger is off duty.

Commissioner Mallozzi would like to address the issues in the Resolution.

Commissioner Shrouder would like staff to codify in writing the rules and regulations.

Interim Director Vega stated he understands the high cost of maintenance and replacement for the fields. He advised staff can look into some options and present them to the Commission.

Commissioner Shrouder would like a policy on what specifically is prohibited and who will enforce the rules.

Commissioner Mallozzi said there is also an issue during daytime hours with professional leagues using the fields.

Commissioner Shrouder said staff needs to include all hours in the analysis.

19. Resolution 23-1 (Commission)

City Attorney Horowitz read "A RESOLUTION OF THE CITY OF COOPER CITY, FLORIDA, AMENDING RESOLUTION NO: 05-5-1, AS AMENDED, BY FURTHER AMENDING THE ADMINISTRATIVE PROCEDURES AND POLICIES FOR THE CONDUCT OF CITY COMMISSION BUSINESS; PROVIDING FOR CONFLICTS; PROVIDING FOR AN EFFECTIVE DATE: by title.

Commissioner Katzman would like to remove no member of the City Commission may attend more than three City Commission meetings by CMT per year as it is not enforceable.

Consensus was reached to remove no member of the City Commission may attend more than three City Commission meetings by CMT per year.

Commissioner Katzman would like public comment times to be consistent. He would like to have agenda concerns and public comments to be listed together as well. He suggested three minutes.

Mayor Ross asked if the Commissioner is suggesting three minutes for additional public comments as well. Commissioner Katzman answered yes.

Consensus was reached for a three minute standard for all public speaking.

MOTION: Commissioner Shrouder moved to approve Resolution 23-1 as amended removing no member of the City Commission may attend more than three City commission meetings by CMT, and providing for a three minutes consistency for public speaking. Commissioner Katzman seconded the motion which prevailed by a unanimous roll call vote. (5-0)

ORDINANCES ON SECOND READING (Public Hearing)

20. Ordinance-23-10 (Commission)

City Attorney Horowitz read " AN ORDINANCE OF THE CITY OF COOPER CITY, FLORIDA, AMENDING CHAPTER 6 OF THE CODE OF ORDINANCES, ENTITLED "BUILDINGS AND BUILDING REGULATIONS," TO AMEND ARTICLE VIII, ENTITLED "VACATION RENTALS;" BY PROVIDING FOR ADDITIONAL PERMIT REQUIREMENTS, NOISE MONITORING DEVICES, DEFINING MAXIMUM OCCUPANCY REQUIREMENTS, AND PROVIDING FOR ADDITIONAL PENALTIES AND ENFORCEMENT INCLUDING DESIGNATING NOISE VIOLATIONS AS A HEALTH, SAFETY, AND WELFARE VIOLATION WITH EXPEDITED ENFORCEMENT; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING AN EFFECTIVE DATE." By title.

Mayor Ross opened the public hearing with no one wishing to speak. Mayor Ross closed the public hearing.

MOTION: Commissioner Katzman moved to approve Ordinance 23-10. Commissioner Mallozzi seconded the motion which prevailed by a unanimous roll call vote. (5-0)

Commissioner Shrouder asked that in Resolution 23-1 Town Clerk be revised to City Clerk.

Mayor Ross asked if item 18 could be considered.

Commissioner Shrouder asked if they could have a discussion on the item as he needs clarification.

Mayor Ross said Commissioner Beam Furr from the County and himself have visited with several Commission and Council's to educate the elected officials.

Commissioner Shrouder said it looks like this ILA locks the City into the funding mechanism but we do not know what the end product is. He asked who will own the asset. He wants to assure the City is not locked into funding an asset that will be controlled by the County.

Mayor Ross said the power is with the Authority. Mayor Ross suggested moving the item to May 23, 2023 and he will try to have Mr. Furr present.

Commissioner Shrouder suggested seeing when Mr. Furr is available and working around his schedule.

Consensus was reached to have the item placed on either the May 23, 2023 agenda or have a special meeting when Mr. Furr is available.

CITY MANAGER REPORT

Interim City Manager Vega would like to appoint Tim Fleming as Acting Public Works Director, Monica McNaughton as Acting Finance Director and Jason Chockley as Acting Growth Management Director.

MOTION: Commissioner Katzman moved to appoint Tim Fleming as Acting Public Works Director. Commissioner Mallozzi seconded the motion which prevailed by a unanimous roll call vote. (5-0)

Commissioner Katzman moved to approve Monica McNaughton as Acting Finance Director.

Commissioner Shrouder seconded the motion for discussion.

Commissioner Shrouder disagrees as Ms. McNaughton is not a CPA and advised we may need to bring in an Interim Finance Director as the Auditors are required to rely on staff for assistance and she has only been with the City for six months.

Commissioner Katzman asked the reasoning behind the CPA requirement for the Finance Director as many City's do not require the CPA certification.

Commissioner Shrouder asked why they need to delegate an Acting Interim. City Manager Vega said the Finance Director signs off on the check runs and the investments. Commissioner Shrouder is not comfortable with delegating authority on an interim basis for financial items without the individual having the qualifications. The Assistant Finance Director can sign off on checks but he is not comfortable with delegating authority over the investment funds.

Mayor Ross asked the time frame on the hiring of the CFO. Interim Director Vega stated interviews are ongoing but he does not have a solid time frame.

Mayor Ross asked if there is need to have an Acting Finance Director. City Attorney Horowitz said without having the job descriptions in front of him, there may be certain authority that the Finance Director has that the Assistant Finance Director would not have, and you may need somebody in that capacity. One option that you could do is appoint an Acting Finance Director and limit that person's authority in the context of investments if that is a concern.

Commissioner Shrouder needs to review the job description before he appoints someone who has only been with the City six months authority to handle the City's finances.

Commissioner Katzman withdrew his motion and asked that the Interim City Manager bring the job description back to the Commission for discussion.

Commissioner Shrouder said Mr. Chockley has been with the City for 20 years and he is uncomfortable with delegating Audit and financial authority to an individual who does not have the experience.

Commissioner Green asked if there is anyone in the Finance Department with a CPA. Interim City Manager Vega answered not that he is aware of.

Commissioner Mallozzi said if we bring on a firm we would not know their capabilities either. She recommends leaving the Assistant Finance Director in the role she is in and having the Interim City Manager act as her right hand and everything goes through him. She can consistently look at the finances and if something requires urgent action she alerts the Interim City Manager.

Commissioner Green said they are placing a lot of burden on the shoulders of Interim City Manager. He prefers hiring a firm to assist.

Interim City Manager Vega said the Finance Department is spread thin. They are trying their best to finish the audit and Ms. McNaughton has stepped up to handle the day to day operations and he believes she should have the opportunity to step in as the Interim.

Commissioner Shrouder said there should be a succession plan in place and the Finance Department continues to have issues. Personally he would consider hiring a consultant as the current Assistant Finance Director does not have Florida government experience and he is not comfortable with having her handle \$30 million dollars.

Commissioner Katzman understands this is a major responsibility and he is not ready to appoint Ms. McNaughton as an Acting Director. However, he is very appreciative of her work. He would like to look into hiring a professional or a firm.

Commissioner Shrouder said he was under the impression Mr. Buffington was asked to step in to assist. Interim City Manager Vega will look into the matter and bring back recommendations to the Commission.

MOTION: Commissioner Katzman moved to appoint Jason Chockley as Acting Community Development Director. Commissioner Mallozzi seconded the motion which prevailed by a unanimous roll call vote. (5-0)

Interim City Manager Vega thanked all staff and elected officials for their participation in Relay for Life. He also thanked the Parks and Recreation Department for their hard work in helping the City receive the Autism-Friendly designation. He also thanked the Commission for giving him the opportunity to lead the City the next six weeks.

Commissioner Katzman wants to assure the individuals working in an acting capacity will be compensated properly. Interim City Manager Vega said the policy states they will receive either a 10% increase or the lowest range of that position.

Mayor Ross said Ms. McNaughton is also doing additional work.

Commissioner Green said Ms. McNaughton should be compensated for leading the department.

Commissioner Shrouder said there is a difference between operational needs and financial requirements.

Interim City Manager Vega said they are looking to bring in a consultant to help with the audit but Ms. McNaughton has been running the day to day operations.

Commissioner Shrouder said the Finance Department has failed under leadership for a while now. Interim City Manager Vega said he understands that is a young department. Commissioner Shrouder said the Finance Department has had added positions and still enlists the help of consultants. The department has been mismanaged which he has witnessed in reviewing the departments time sheets. The Budget Analyst is working on accounts payable and the Customer Service Supervisor for Utilities has additional accounting roles.

Commissioner Green said the previous Customer Service Supervisor left so the need to fill the position arose. He understands the Finance Department has had difficulties but they have been given additional work from previous Commission's. He believes Mrs. McNaughton should be compensated.

Commissioner Mallozzi understands both Commissioner Shrouder and Green and asked for a compromise with a 5% temporary increase.

Commissioner Shrouder would rather wait to see what Interim City Manager Vega brings back for options.

Interim City Manager Vega will bring back options at the next regular City Commission Meeting.

CITY ATTORNEY REPORT

City Attorney Horowitz advised on Thursday April 27, 2023 the City will have a Collective Bargaining meeting in the Chambers at 4:00 PM.

Commissioner Mallozzi said collective bargaining sessions are not normally done in the sunshine.

City Attorney Horowitz advised collective bargaining sessions are always done in public. Closed door sessions can be requested under the statue by the City Manager.

POLICE CHIEF'S REPORT

21. Police Chief's Report

Captain De Giovanni advised there has been an uptick of cases with unsanctioned car shows and rally's. One instance happened on April 15th in the local plaza on Griffin Road. District 16 was able to disperse the crown before the group arrived and the code was enforcement with the business owner that invited the group. The most recent Code Enforcement sweep resulted in 124 violations that were addressed. 83 were warnings, 23 actual violations and 18 for parking. He also advised the Real Time Crime Center is complete and this is a major milestone in the City. A grand opening will be held on June 14, 2023. The will also have a secondary event for the public to attend. He is hopeful to have the Sergeant position filled by the next Commission Meeting. He also advised his team will be alongside the Special Olympics in the torch run tomorrow morning representing the City of Cooper City. They are also working on having an autism wrapped vehicle to showcase the City's efforts. He also asked for clarification on citing for a roster present in a residential area.

Commissioner Shrouder does not believe farm animals should be allowed in the City except for in the overlay districts.

City Attorney Horowitz would like to bring forth a recommendation with regard to roosters and foul.

Mayor Ross asked if a citation was issued with regard to the unsanctioned car show. Captain De Giovanni advised he did send Code Enforcement out to issue a violation and that same day the plaza transferred ownership to a new owner. He is researching the ability to cite the new owner. Mayor Ross also asked for an update on the SRO situation. Captain De Giovanni said the School Board authorized a \$103,000 reimbursement per SRO. Which equals \$209,000 additional funds of reimbursement for five SRO's. Interim City Manager Vega advised he met with other BSO cities who are going to accept the \$103,000 for this year and then go back to negotiations for the next three years.

Mayor Ross asked if the acceptance is done by the City or BSO. City Attorney Horowitz said the City would accept the funds. Captain De Giovanni said BSO has historically negotiated the SRO contract on the City's behalf.

FIRE CHIEF'S REPORT

22. Fire Chief's Report

Chief Harrington advised he did a final inspection of the City's new engine which went well besides some cosmetic issues. The vehicle should be delivered in a few weeks.

Commissioner Mallozzi asked where in Davie we responded to specifically as stated in his report. Chief Harrington will look into the areas they responded to. Commissioner Mallozzi asked if Davie needs to reallocate their units to better suit their City if the calls are specifically in one area.

Commissioner Shrouder said for some areas we may be closer than Davie and Davie may be closer to some of our areas.

Commissioner Katzman asked how long it takes to mount the equipment and having the apparatus in working order. Chief Harrington answered a few weeks.

Commissioner Shrouder wants to assure the vehicle is insured.

COMMISSIONERS' CONCERNS/REPORTS/ITEMS TO BE PLACED ON NEXT AGENDA

Commissioner Green thanked everyone who supported the Autism Awareness event and the Relay for Life event.

Commissioner Katzman thanked Mr. Vega for stepping up and his hard work. He thanked all Parks and Recreation staff for their hard work on the Autism-Awareness designation and the Relay for Life event.

Commissioner Mallozzi thanked the Parks and Recreation Department for their hard work on the Relay for Life event.

Mayor Ross spoke on his concerns with inconsistences with the Commission. He asked if Tim Fleming has the necessary education background for the Interim position. Interim City Manager Vega will obtain the information. He also took issue with two instances with regard to the last Commission Meeting. He advised he was lectured about being an elected official by Commissioner Green but his words led to a conclusion. He also had a concern with Commissioner Shrouder not being able to speak on an item he brought up during Commissioner Concerns last week. So then offered Commissioner Shrouder the opportunity to speak.

Commissioner Shrouder said he wanted to discuss the loss of the Public Works Director over miscommunications. He believes there was a miscommunication over what was said about Mr. Good and we lost an individual with vast knowledge and experience.

Mayor Ross would like to see Mr. Good's exit interview. Interim City Manager Vega will send the information to the Commission.

Commissioner Shrouder was hoping there was a way to clear the air.

Mayor Ross gave Commissioner Green an opportunity to respond.

Commissioner Mallozzi said he has not given the opportunity in the past for response.

Mayor Ross advised he tried to be inclusive but was unsuccessful.
