## **AGENDA**

#### **PLEDGE OF ALLEGIANCE**

Mayor Ross opened the meeting at 6:30 PM and led the assembly in the Pledge of Allegiance

#### **ROLL CALL**

Present were Commissioners Shrouder, Meltzer, Green, and Mayor Ross. Commissioner Pulcini was absent.

#### **PUBLIC COMMENTS (4 MINUTES)**

No public comments.

#### **TOPICS FOR DISCUSSION AND APPROVAL**

Motion to approve redistricting map for City of Cooper City - Community Development

James Gammack-Clark, from the Florida Atlantic University (FAU) Department of Geosciences reintroduced himself and noted he is following up from last week's presentation and will be presenting the redistricting alternatives.

He reviewed the agenda for tonight's meeting and reintroduced the redistricting team. The other team members are Dr. Bourassa, Chair of the Department and Regional Planning and Dr. Schultz from FAU's Department of Geosciences.

Mr. Gammack-Clark recapped the provisions of the City Charter, which established four (4) election districts, encompassing as close to one-quarter of the total City population as possible. No election district should have population variance of more than 10% of any other election district.

He stated the data that was used came from the 2020 U.S. Census. Additionally, housing data was provided by City staff in order to create a population projection out to 2023.

As discussed last week, he noted, the districts are currently unbalanced. The total deviation is 27.77% between all four districts and has a spread of 13.6%. He stated this exceeds the 10% deviation as outlined in the City Charter.

Mr. Gammack-Clark stated the redistricting parameters they follow are:

- Reasonable population balance across the districts
- Adhere to Section 2 of the 1965 Voting Rights Act, which states arbitrary dilution of minority population classes is prohibited
- Seeking geographic contiguity
- Population equality is the driving factor

Mr. Gammack-Clark stated they created four (4) alternatives that meet standard districting guidelines and the requirements of the City Charter. They represent alternate ways to better balance the district

populations. The overall pattern of district boundary changes was to reduce the population in District 1 and expand in Districts 3 and 4. He clarified the  $4^{th}$  alternative is actually 3b and just a slightly different version of Alternative 3. He presented the following alternatives:

#### 1. Alternative 1

- a. Represents a minimalist approach
- b. Moved territory from District 1 to District 2 and from District 2 to District 4
- c. No change made to District 3
- d. Absorbed the non-parcel on SW corner of Stirling Rd and NW 89<sup>th</sup> Avenue
  - i. Also included in Alternative 2
- e. Major change is in current projections, there will be 705 people greater than ideal average in District 1. This move corrects that imbalance
  - i. Also included in Alternative 2
- f. Cooper Colony Estates remains split but is more logical
- g. Hibbs Grove moved from District 2 to District 4 and affects 496 residents and does approve overall spatial compactness
- h. In this alternative, the total deviation falls to 10.17%, the mean deviation falls to 2.54%, and the spread falls to 9.77%
- i. This alterative does have the highest spread of all the alternatives

Mayor Ross asked why their information only includes the deviation from the average data and not all the percentages which are being presented on the screen. Staff clarified they will print the presentation which includes all information.

#### 2. Alternative 2

- a. Seeks to improve population balance and improve geographic compactness
- b. Moved territory from District 1 to District 2, from District 2 to District 3, and from District
   2 to District 4
- c. Hibbs Grove is moved from District 4 to District 3
- d. In current population projects, District 3 is 425 people fewer than the ideal average. With the addition, the total population will become 8,710, which is 10 above the ideal average
- e. In current configuration, District 4 has 478 fewer residents than the 2023 projection
- f. The following neighborhoods are moved from District 2 to District 4: Royal Palm Ranches, Stirling Village, and Diamond Head. Collectively, they have a population of 789 people
- g. In this alternative, the total deviation of District 4 falls to 3.5%
- h. In this alternative, the total deviation falls to 7.37%, the mean deviation falls to 1.84%, and the spread falls to 7.0%

#### 3. Alternative 3

- a. Reorganize the districts into four (4) quadrants
  - i. Stirling Road serves as the North South dividing line
  - ii. Palm Avenue serves as the East West diving line
- b. The following neighborhoods are moved from District 2 to District 1: Royal Palm Ranches, Stirling Village, and Diamond Head
- c. Absorb southern half of Embassy Lakes found south of the FPL easement
  - i. It does divide Embassy Lakes down a manmade barrier
- d. Move 4,117 into District 2 by moving part of District 1 north of Stirling Road

- i. Would unify Cooper Colony Estates
- e. Build on District 3 by adding Palm Avenue in the east, Hiatus Road in the west, and Stirling Road in the north and the FPL easement
- f. Would improve compactness for District 4
- g. Would establish the desired NE, NW, SE, and SW quadrants
- h. The total deviation falls to 6.8%, the mean deviation falls to 1.7%, and the spread falls to 5.56%
- i. Has the lowest average deviation and lowest spread of all alternatives

#### 4. Alternative 3b

- a. Improves compactness and population equity
- b. Would establish the desired NE, NW, SE, and SW quadrants
- c. The total deviation falls to 12.2%, the mean deviation falls to 3.07%, and the spread falls to 9.31%

Mr. Gammack-Clark concluded by sharing all alternatives reduce the population differences amongst the four (4) districts.

Commissioner Meltzer thanked Mr. Gammack-Clark for the presentation. He noted the Commission must address the ambiguity in the City Charter about the 10% variance. He stated if you look at Alternative 1, it doesn't work both ways. He believes Alternative 1 violates the Charter.

Commissioner Meltzer also asked what defines a residential community. He stated he went to Wikipedia for a definition. He shared it was defined as "a community usually a small town or city composed to residents compared to commercial." He suggested the Charter is open to interpretation.

Commissioner Shrouder stated community would need to be defined as the smallest unit. He suggested it may have to get down as small as subdivisions. He suggested Alterative 3 makes the most sense with numbers, as they are the lowest deviation but has concerns about the SW part of Embassy Lakes to District 1.

Mayor Ross agreed with Commissioner Shrouder and asked why 1 and 3 on the map cannot be switched.

Mr. Gammack-Clark responded that would work and could be considered Alternative 3c. He said they were considering future flexibility when they were drawing the map.

Mayor Ross Alternative 3c seems to be the best and most fair to all involved.

Mr. Green clarified the suggestion is in Alternative 3 or 3b to switch the northern part of Embassy Lakes with the southern part of Embassy Lakes. The northern part will become part of District 1 and the southern part will become part of District 3.

He asked how many homes or people would be affected.

Mr. Gammick-Clark noted it would be less than 96 affected. He noted they can switch the two halves of Embassy Lakes as suggested.

Mr. Green asked if Alternative 3 would affect the Charter.

Mr. Gammick-Clark clarified that Alternative 3 might be contrary to the City Charter. He noted when redistricting at the municipal level, it is standard practice to try not to divide neighborhoods, but it is almost impossible. He reiterated population equity is the primary driver.

Mayor Ross asked if the Charter changed and there were no districts, would they need to go through the redistricting process.

Mr. Gammick-Clark responded even if the City was running at-large, he believes there should still district represents pockets of residents.

City Attorney Horowitz responded that would be a significant change to the Charter and quite a few provisions would be impacted. He noted there are some municipalities that have no districts and there are associated benefits and risks and several methods by which city officials are elected.

City Attorney Horowitz shared his observations. He stated State law tells us that districts need to be as nearly equal in population as possible and that by providing equal population, we are not interfering with rights. The Commission has flexibility for local districts but not to be drawn with the intent to abridge minority rights, to favor any political party or diminish voters' election rights. The districts must be contiguous and can't conflict with residents' rights. He also shared there is case law that speaks to districts being compact and unnecessary shapes or appendages avoided when possible. He believes the proposals presented satisfy both State law and federal law. He agreed residential communities can be defined in several ways and the Commission has the authority in the context of interpretation.

Commissioner Shrouder asked what whether the more important factor is the Charter or the State law.

Mr. Horowitz responded, ultimately, the State and Federal law would prevail over the Charter.

Commissioner Shrouder asked if they should air more on the side of population equality.

Mr. Horowitz responded population equality and contiguous districts matter significantly.

Commissioner Shrouder asked how would Alternative 3c help the numbers.

Commissioner Green expressed concern with splitting Embassy Lakes. He is in support of Alternative 2.

Commissioner Meltzer expressed concern with splitting communities but noted there is precedent with splitting Cooper Colony Estates. He acknowledged conflicting feelings about Alternative 3 because it will create upheaval but loves the lowest population deviation and geographic configuration.

Commissioner Shrouder doesn't see the change being that large because the City has historically run at-large. He noted the upcoming election will be the first time with specific districts and now is the time to fix the map. He acknowledged that, although Embassy Lakes will be split, no subdivisions within are split.

Before the vote, City Attorney Horowitz stated the consultant would be required, by ordinance, to bring back a revised Alternative 3c map exhibit to be presented to the Commission on first reading. Would need to be submitted by January 2022.

**MOTION:** Mayor Ross motioned to accept Alternative 3c as presented, under the condition of flipping the northern half and southern half of Embassy Lakes. Commissioner Shrouder second the motion which prevailed by the following roll call vote.

NO: Commissioner Green

YES: Commissioner Shrouder, Meltzer, and Mayor Ross

## Resolution 21-53 (Finance/Public Works)

City Attorney Horowitz read "A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF COOPER CITY, FLORIDA, APPROVING AND AUTHORIZING THE EXECUTION OF THE SECOND AMENDMENT TO THE INTERLOCAL AGREEMENT WITH BROWARD COUNTY FOR SOLID WASTE DISPOSAL SUPPORT SERVICES, ATTACHED HERETO AS EXHIBIT "A;" AUTHORIZING AND DIRECTING THE APPROPRIATE CITY OFFICIALS TO TAKE ANY AND ALL ACTION NECESSARY TO EFFECTUATE THE INTENT OF THIS RESOLUTION; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE" by title.

Commissioner Meltzer asked fiscal impact on the staff memo. He asked for clarification on the tipping fee of \$42 per ton.

Assistant Finance Director Natasha Mazzie answered that number was an error. The true number is \$32.77 per residence.

Commissioner Shrouder asked why some fees like Parkland are more per ton but they are paying less on monthly bill. He suggested several areas are paying less per ton, even though they are smaller. Common theme seems to be Waste Pro and where are they taking it to.

Mayor Ross stated different disposal facilities charge different rates.

Assistant Finance Director Mazzie noted a few of the cities mentioned are up for renewal in 2023 as well.

Commissioner Shrouder stated Southwest Ranches pays \$26.90 and they are smaller.

Mayor Ross acknowledged there are a lot of differences but that is why they are trying to get all 31 cities together for the disposal agreement. He said hauling is intertwined and the tipping fee will change.

Commissioner Shrouder expressed concern about getting stuck in tipping and hauling.

Commissioner Meltzer noted they should be mutually exclusive.

Commissioner Shrouder asked if the ILA agreement mandates who provides hauling.

Mayor Ross answered no.

Commissioner Shrouder asked if the agreement mandates where it is disposed.

Mayor Ross responded yes.

Discussed ensued about Wheelabrator.

Commissioner Shrouder asked if they are forced to use Wheelabrator.

Mayor Ross answered the City is not forced but they currently use Wheelabrator. He noted they will look into different facilities with an attempt to get back to 75% recycling. He noted Wheelabrator technically receives recycling credit because they are turning it into energy.

City Attorney Horowitz confirmed this agreement is about disposal and not hauling.

Commissioner Shrouder asked for clarification about Wheelabrator and Waste Management trucks.

Mayor Ross responded that we tell Waste Management who we want to use as a disposal facility. He suggested if all 31 agree, additional facilities will be needed.

Commissioner Shrouder asked if Waste Pro can be contracted as the hauler.

City Attorney Horowitz confirmed they will need to go out to bid for a hauler in 2023.

**MOTION:** Commissioner Meltzer moved to approve Resolution 21-52. Commissioner Green seconded the motion, which prevailed by a unanimous roll call vote (4-0).

#### **ADDITIONAL PUBLIC COMMENTS (2 MINUTES)**

No public comments.

City Manager Napoli noted the item for Lucky Storage Facility at last night's Planning & Zoning meeting was deferred to January 10, 2022.
